- Preparing for Winter Recess Cleaning

-We are still working to resolve electrical issues and hopefully over the next two weeks, all of this should be resolved

-Repair of the stairwell

-The side of the building that was damaged has now been repaired -We have also expanded our Internet service/repair and have Dean, a vendor who is helping us with this area. His fee is \$135/hour and we are looking at his contract to determine how much/frequent we will need his services to come to an agreement

-We are still in the midst of setting up the new Chromebook; insurance is being purchased for the equipment as well. Hard covers were ordered for each Chromebook, and it will take some time to place them on. Hopefully, by the next month or two, all the setup will be complete

-The Fire Alarm still displays zones that are problematic. However, there are nationwide delays that are impacting a resolution to this issue. Efforts are ongoing to resolve the issues.
