Budget presentation by Dr. Jones:

- There was growth observed on the academic data analysis and there was an increase in curriculum platforms utilized.
- Academic Support Staff was increased as well as the addition of a School Nurse
- Provided Instructional staff with coaching and PD, sharing of best practices, and continuing to be culturally responsive with our teaching approaches.
- We had 100% student enrollment and we still there as of today
- -We have a high level of staff retention, and we hope we'll have similar results at the end of this year.
- -We've most importantly ensured the safety of our students, staff and families with increased COVID-19 protocols and hats off to Mrs. Thomas and Mr. Ofstad with the tracker and the weekly testing facilitation, and everyone else on the school staff that have been helpful in making sure the safety and security of everyone particularly our maintenance staff as well, with the Shields and the storage pods; furniture movement, and additional deep cleaning in respect to our facilities this year
- -We submitted grants for building upgrades and increasing security of camera upgrades pending approval from state.
- We added the part time maintenance staff for cleaning during the school day, help with the lunch periods, etc.
- -Continued to provide COVID-19 relief efforts for the community through weekly testing and increase cleaning and PPE for safety
- -With respect to technology we purchased more Wi-Fi and technology, receive support from our database administrator Dean- he's been at the school regularly trying to solve our Wi-Fi issues
- -We also received 300 new Chromebooks for the entire student body from e-rate federal grant funding to ensure 1-to-1.

- -A Director of Technology was hired- Mr. Harris and we also redesigned our website which Ms. Dumenigo has been effortlessly working on through weekly meetings and redesigning the layout
- When you look at our budget and our historical trend for state aid as you can see previous years we had a little lower enrollment but the last few years we were holding steady at 300 with a slight increase in state aid this year, approximately 9% increase.
- Additional items were reviewed line by line and rationale for all budgetary items for board approval and then state submission.
